International Music Competition City of Fano 1st Edition 2021 Clarinet 17-18-19 September 2021 Fano (PU) - Italy

Regulation

Art. 1 - Purposes and objectives

- 1. The Cultural Association "Art and Music", in collaboration with Cassa di Risparmio di Fano Foundation and with the patronage of the Municipality of Fano, organises the "International Music Competition City of Fano" with the aim of disseminating musical culture, highlight and enhance the artistic personality of the competitors and at the same time promote the name and image of Fano.
- 2. The "International Music Competition City of Fano" is aimed at clarinetists of any nationality between the age of 15 years old and 35 years old on the expiry date of the registration deadline.
- 3. The competition aims to enhance the technique, interpretation and musicality of each competitor which will be subject to an evaluation, in the competition, by a jury.

Art. 2 - Selections

- 1. The selections can be accessed as indicated in the following regulations of the Competition.
- 2. The competition is divided into two tests.
- 3. The Direction of the competition is entrusted to the Artistic Director.

Art. 3 - Acceptance and Selections

- 1. Registration must take place by 12.00 on 25 August 2021 Italian time, by filling out the online form available at www.fondazionecarifano.it/bandi/ which requires the following information / documents:
- a. Personal data, contact details, consent to the processing of personal data.
- b. Scan of the receipt for payment of the registration fee of 25.00 euros (twenty-five / 00

euros) - or equivalent in the local currency of your country - to be paid by bank transfer to: Cultural Association "ARTE e MUSICA", Via Vitruvio, 9 - Fano, IBAN IT11R 08519 24308 0000 0000 0945, BIC ICRAITRREFO indicating the reason "competitor registration fee". The amount must be net of the commissions of the ordering bank.

- **c.** Copy of a valid document (identity card or passport) with personal data and clearly visible photo.
- **d.** Video of the performance of one of the pieces, chosen as desired, from the list in Article 6 paragraph 2 which will be evaluated by the jury for acceptance to the selections.
- **2.** By sending the registration form, the competitor / parent / guardian declares to accept to be accompanied by a pianist made available by the organizer or by their accompanying personal pianist.
- **3.** By registering, you are informed that there are no reimbursements for travel, board and lodging expenses for both the competitor and any pianist. The organizer undertakes to offer to competitors who come from afar favorable accommodation conditions (hotels) in agreement with the local hoteliers.
- 4. The registration fee will not be refunded for any reason, unless the competition is cancelled by the organization.

Art. 4 - Selections and Final

- 1. The applications received will be screened by the jury on the basis of the video test sent together with the registration and chosen from one of those indicated in the list in Article 6 paragraph 2; a maximum of n. 25 competitors will be chosen for the execution of the final selections in physical presence, at the Pinacoteca San Domenico in Fano, in the presence of the jury, where the best 3 competitors will be chosen (with possible ex aequo) who then will be entitled to the prizes put in palio.
- 2. The selections will take place at the San Domenico Art Gallery in via Arco d'Augusto in Fano, (PU), on 17, 18 and 19 September 2021 according to the times that will be communicated to the chosen competitors. By 1.00 pm on September 19th the jury will nominate the 3 finalists (including any ex aequo). In the afternoon of the same day, again at the Pinacoteca San Domenico in Fano, there will be a final concert open to the public in which the best classified will participate, who will be asked to perform again the piece chosen for the selection, or another one of their choice from the list in Article 6 paragraph 2, with the exception of the one sent during registration. At the end, the winner will be announced, as well as the second and third classified with any ex aequo.
- 3. Competitors can use the headquarters of the "Art and Music" Association of Fano for a short warm-up test before performing at the Competition.

Art. 5 - Jury

- 1. The Jury is made up of internationally renowned Italian / foreign musicians and the Artistic Director of the Competition.
- 2. The Jury, in the selections, reserves the right to interrupt the competitor's musical performance at any time and may decide to have only part of the musical program performed.
- 3. At the end of the performance of the tests, the Jury meets in private to comment on the evaluation of the competitors.
- 4. The Competitor, both before and after the performance, is not allowed to speak with the Jury.

Art. 6 - Executions

- 1. The organization, in order to better encourage the participation of competitors, also integrates pieces for solo clarinet into the program.
- 2. During the selections, the competitor must perform a piece chosen from those indicated in the following Music Program, different from the one sent at the time of registration.

- a. The First Prize is awarded to the winner of the Competition and is indivisible.
- **b.** The Jury has the right not to assign the 1st Prize.
- **c.** In case of non-assignment of the 1st prize but an ex aequo of the 2nd prize, the competitors will receive the full sum of the 2nd prize. There is no ex aequo of the 3rd prize. If there will be a 1st, a 2nd and a 3rd, they are not expected ex aequo.
- **d.** During the finals, after the performances of the three finalists, the winner will be announced in the presence of the authorities of the Foundation, the Municipality of Fano and the Director of the G. Rossini Conservatory of Pesaro.
- **e.** The aforementioned bonuses are subjected to the taxes provided for by the Italian tax laws in force.
- **f.** Pursuant to Article 13 of Legislative Decree 196/2003 (hereinafter the "Privacy Code) and art. 13 of EU Regulation 2016/679 (hereinafter "GDPR 2016/679), the Organization is the data controller for the processing of the personal data of competitors and members of the Jury.
