Regulation

Art. 1 - Purposes and objectives

1. The Cultural Association "Art and Music", in collaboration with Cassa di Risparmio di Fano Foundation and with the patronage of the Municipality of Fano, organises the "International Music Competition City of Fano" with the aim of disseminating musical culture, highlight and enhance the artistic personality of the competitors and at the same time promote the name and image of Fano.
2. The "International Music Competition City of Fano" is aimed at clarinetists of any nationality between the age of 15 years old and 35 years old on the expiry date of the registration deadline.
3. The competition aims to enhance the technique, interpretation and musicality of each competitor which will be subject to an evaluation, in the competition, by a jury.

Art. 2 - Selections

1. The selections can be accessed as indicated in the following regulations of the Competition.
2. The competition is divided into three tests.
3. The Direction of the competition is entrusted to the Artistic Director.

Art. 3 - Acceptance and Selections

1. Registration must take place by 12.00 on 31 august 2023 Italian time, by filling out the online form available at www.fondazioneclarifano.it/bandi/ which requires the following information / documents:
 - a. Personal data, contact details, consent to the processing of personal data.
 - b. Scan of the receipt for payment of the registration fee of 25.00 euros (twenty-five / 00 euros) - or equivalent in the local currency of your country - to be paid by bank transfer to: Cultural Association "ARTE e MUSICA", Via Vitruvio, 9 - Fano, IBAN IT11R 08519 24308 0000 0000 0945, BIC ICRAITREF0 indicating the reason "competitor registration fee". The amount must be net of the commissions of the ordering bank.
 - c. Copy of a valid document (identity card or passport) with personal data and clearly visible photo.

d. Video of the performance of two of the pieces, chosen as desired, from the list in Article 4 paragraph 1 which will be evaluated by the jury for acceptance to the selections. The selections will take place at Pinacoteca San Domenico, via Arco d'Augusto, Fano (PU) on the 15th September 2023.

2. By sending the registration form, the competitor / parent / guardian declares to accept to be accompanied by a pianist made available by the organizer or by their accompanying personal pianist.

3. By registering, you are informed that there are no reimbursements for travel, board and lodging expenses for both the competitor and any pianist. The organizer undertakes to offer to competitors who come from afar favorable accommodation conditions (hotels) in agreement with the local hoteliers.

4. The registration fee will not be refunded for any reason, unless the competition is cancelled by the organization.

Art. 4 - Selections and Final

1. The applications received will be screened by the jury on the basis of the two video test pieces sent together with the registration and chosen from:

First piece

a. G. Donizetti, Studio Primo

or

b. Kovács, Hommage a Strauss

Second piece: C. M. Von Weber, Concertino op. 26

Of the applications received, a maximum of n. 15 competitors will be chosen for the semi-final selections in physical presence, at Pinacoteca San Domenico in Fano, on the 15th September 2023.

During the selections the competitor must perform two pieces chosen from those listed below:

First piece: I. Stravinsky, Three pieces for solo clarinet

Second piece chosen from:

a) J. Brahms, sonata op.120 n.1 in F minor

or

b) C. Debussy, Première Rhapsodie

On the 16th September 2023 there will be the final in physical presence, at Pinacoteca San Domenico. The finalists, in front of the jury, must perform "Mozart, Concerto KV 622". At the end of the final, the winner will be announced, as well as the second and third classified.

On the 17th September 2023 at Pinacoteca San Domenico in Fano, concert open to the public and in the presence of the authorities of the Foundation, the Municipality of Fano which will be attended by the first, the second and the third classified.

2. Competitors can use the headquarters of the "Arte e Musica" Association of Fano, from the afternoon of September 14th and in the following days of the Competition, for a warm-up test before the performance, with their own pianist or with the one available from the organizers.

Art. 5 - Jury

1. The Jury is composed:

- M° Sauro Nicoletti – Artistic Director
- M° Enrico Maria Baroni – 1st Clarinet Orchestra Nazionale della Rai

- M° Giuliano Giuliani –Oboe and english horn Orchestra Sinfonica Teatro di Bologna
- M° Fabrizio Meloni – 1st clarinet Orchestra del Teatro alla Scala
- M° Patrick Messina – 1st clarinet Orchestre National de France

2. The Jury, in the selections, reserves the right to interrupt the competitor's musical performance at any time and may decide to have only part of the musical program performed.

3. At the end of the performance of the tests, the Jury meets in private to comment on the evaluation of the competitors.

4. The Competitor, both before and after the performance, is not allowed to speak with the Jury.

Art. 6 - Executions

1. The organization, in order to better encourage the participation of competitors, also integrates pieces for solo clarinet into the program.

Art. 7 - Awards

1st Prize € 2,500.00

2nd Prize € 1,500.00

3rd Prize € 500.00

a. The First Prize is awarded to the winner of the Competition and is indivisible.

b. The Jury has the right not to assign the 1st Prize.

c. In case of non-assignment of the 1st Prize, there will be an ex aequo of the 2nd Prize only. In this case, the competitors will receive the full sum of the 2nd Prize.

e. The aforementioned bonuses are subjected to the taxes provided for by the Italian tax laws in force.

f. Pursuant to Article 13 of Legislative Decree 196/2003 (hereinafter the "Privacy Code) and art. 13 of EU Regulation 2016/679 (hereinafter "GDPR 2016/679), the Organization is the data controller for the processing of the personal data of competitors and members of the Jury.
